- Candidates may not date pupils, parents of pupils enrolled in the school, or school or University personnel during the clinical experience.
- No socializing with school pupils except in an official capacity at officially sponsored school events.
- No drinking, smoking, ore being under the influence, or be in the
 possession of alcoholic beverages or illegal drugs on school property,
 nor with or in the presence of any school pupil(s).
- No using sexually explicit, obscene, profane, abusive, or derogatory language on school premises or at school-sponsored event; nor may they suggest access to inappropriate material.
- Candidates may not take pupils off school property unless accompanied by the clinical educator or another full-time employee.
- Leaving school early, being late to school or seminars, or have absences on a consistent basis.
- Exhibiting any behaviors that interfere with the school's learning environment.
