Student teaching placement requirements:				
Minimum number of observations for field instructor (not including the midpoint three-way conference and the final conference)		<ul> <li>5 observations are scheduled during the year.</li> <li>There will also be three visits in each of the fall and spring semesters. These will serve as an orientation, midpoint, and final conferences.</li> </ul>		
Passing criteria for the Capstone Clinical Experience Evaluation		<ul><li>At least half of the indicators must have a score of 3 or above.</li><li>There can be no scores of 1.</li></ul>		
Attendance policy	<ul> <li>Teacher candidates/interns are considered professional staff and are required to adhere to the district calendar and to the program-specific student teaching schedule.</li> <li>Teacher candidates follow the teacher hours in their school. Absences from the field will be considered excused only in accordance with University Policy.</li> </ul>	<ul> <li>Call your clinical educator and the UD clinical coordinator if ill and unable to attend placement. Plans must be sent to the clinical educator so they can take over.</li> <li>All appointments must be made outside of school time.</li> </ul>		
Policy for making up missed time in placement		• All time from absences and school closings must be made up.		

Grounds for removal from placement	<ul> <li>Misconduct by teacher candidates will be reported to the University's Office of Student Conduct. Teacher candidates found in violation of UD's Student Code of Conduct may be removed from their field placement and/or prohibited from future field placements.</li> <li>If a teacher candidate does not pass a student teaching placement, then they can request a new placement. If this is denied, the student can appeal the decision, in writing, to the University Council on Teacher Education.</li> </ul>	<ul> <li>Candidates may not date pupils, parents of pupils enrolled in the school, or school or University personnel during the clinical experience.</li> <li>No socializing with school pupils except in an official capacity at officially sponsored school events.</li> <li>No drinking, smoking, or being under the influence, or be in the possession of alcoholic beverages or illegal drugs on school property, nor with or in the presence of any school pupil(s).</li> <li>No using sexually explicit, obscene, profane, abusive, or derogatory language on school premises or at school-sponsored event; nor may they suggest access to inappropriate material.</li> <li>Candidates may not take pupils off school property unless accompanied by the clinical educator or another full-time employee.</li> <li>Leaving school early, being late to school or seminars, or have absences on a consistent basis.</li> <li>Exhibiting any behaviors that interfere with the school's learning environment.</li> </ul>
