Maryland

The following instructions were written for Early Childhood Education students who attend the University of Delaware but have lived in Maryland and need to obtain those out-of-state clearances. If you are not a UD student, you will need to contact the state directly for additional help.

Criminal Record Check Services:

- Go to <u>DPSCS Fingerprint Services (maryland.gov)</u>
 - There is a list of Motor Vehicle Administration office locations that are open for fingerprinting.
 - You will need to call to make an appointment: 410-764-4501 or 888-795-0011
- Fill out the <u>Livescan Pre-Registration Application</u>.
 - Fill out the Applicant Information completely.
 - For the Reason for Request, select Individual Review. Use your name and address for the mailing Information.
 - Since you are using an Individual Review, you do not need to fill out the Agency information.
- You only need the state results. You do not need to request an FBI criminal history record (that is taken care of when you are fingerprinted in Delaware).
- Bring the Application, a government-issued ID (your driver's license or passport), and payment (major credit card, cash, or money order).
- Once you receive your results, you must send them to our office. You can do this by scanning them to <u>clinicalstudies@udel.edu</u>.

Adam Walsh/Child Protective Service Background Record Request:

- You must finish filling out the form, then get it notarized. A list of notaries on campus can be found: https://waitwhile.com/book/registrar875/service. When you sign the form, you will need to use BLUE ink.

- You must return the completed form to the local CPS in the Maryland jurisdiction where you currently reside. A list of your local facility can be found: <u>https://dhs.maryland.gov/child-protective-services/reporting-suspected-child-abuse-or-neglect/local-offices/</u>.
